The Green Investment

The Green Investment Declaration is a collaboration between Operation Noah and JustMoney Movement to support Churches and other faith institutions to increase their investments in climate solutions to build a greener future. Depending on where you are on your green investment journey, your organisation will start on one of three levels of this Declaration. As your green investments grow, so too will your Green Declaration, moving from an acorn, to a thriving sapling, to a mighty oak tree.



As well as taking action toward ethical finances, The Green Investment
Declaration will offer dioceses an opportunity to provide evidence of fulfilling the criteria for silver Eco
Diocese; The sapling level of the Green Investment Declaration, demonstrates the start of a journey of
investing for positive environmental impact, an intention to invest further in this area, and have shared this
publicly to encourage others to do likewise.

Just Money Movement

Operation Noah works with churches of all denominations to address the climate crisis, particularly through their divestment campaign, Bright Now, and a new initiative to promote green investment. They are also working with churches on large-scale, nature-based solutions, from increasing tree cover to other environmentally sensitive ways of managing church land.



Christian Climate Action

Ethical Banking is a current issue for <u>Christian Climate Action</u> and actioned via their 'Drop Barclays' campaign as Barclays has been the biggest funder of fossil fuels in Europe since 2016.
